D2C Industry Immersion Programs (Immersion Programs)

D2C Industry Immersion Programs provides a platform for industry to facilitate students learning about careers in construction and to support SA Government's Career Education and Pathways Strategy (CEPS).

Immersion Program Objectives

The objectives of the Immersion Programs are:

- 1. Exposure to Career Paths and Employers: Provide firsthand exposure to various construction apprenticeship pathways through real life experiences and industry collaboration, including trades with limited apprenticeship uptake. Achieve a positive change in student sentiment towards a career in construction.
- **2. Preparation for D2C:** Equipping students with skills for future success in the industry while meeting VETRO requirements for D2C FIPs and Advanced Skills Programs.
- **3. Promoting Diversity and Inclusion:** Promote diversity through initiatives like Women in Construction and First Nations Programs, welcoming students from all backgrounds.
- **4. Building Collaborative Networks:** Foster collaborations among schools, students, Registered Training Organisations (RTOs), Group Training Organisations (GTOs), employers, and industry associations, establishing a robust network for future careers in construction.
- **5. Pipeline of Skilled Workforce:** Increase student participation in Doorways2Construction and facilitate a smooth transition into school-based apprenticeships and apprenticeships.

Immersion Program Criteria

Immersion programs that CITB will fund <u>must</u> include hands-on activities, be interactive and connect with industry (see below). Additionally, immersion programs will meet the following criteria:

Funding

Training Subsidy:

\$20.00 per hour per student

Cap: \$1,800.00 per day (this is based on 15 students and is equivalent to \$20.00 per student/hour).

Funding will be adjusted if minimum student numbers are not reached by \$120.00 per student.

With prior notification, flexibility on numbers may be considered for programs delivered regionally or to diversity groups.

Regional Subsidy:

This support is a contribution only and is not intended to cover the total travel and accommodation costs of a provider.

Travel:

0.40c per km for providers travelling over 80km from their registered premises to deliver immersion programs. **Cap: \$500 each way.**

Accommodation:

\$150 per night

Cap: 5 nights (one trainer only)

Example 1:

Happy Training, in Albert Park, are planning to deliver a three day immersion program to Port Lincoln High School.

A return trip from Port Lincoln to Albert Park is 1,290km.

Total subsidy eligible:

Travel to: $645 \text{ km} \times 0.40c = \258.00 Travel from: $645 \text{ km} \times 0.40c = \258.00 Total travel subsidy = \$516.00

Accommodation for three nights: $3 \times 150 = 450$

\$516 + \$450 = \$966

Example 2:

Happy Training, in Albert Park, are planning to deliver a five day immersion program for students in Whyalla. Happy Training also have a campus in Port Augusta.

A trip from Port Augusta to Whyalla is 76 km. This is not eligible for any regional subsidy.

GST:

GST is included in CITB funding. This will be defined within the agreement.

Conditions:

Funding recipients must:

- Be registered with CITB as an Endorsed Training Providers (ETPs) or Endorsed Group Training Organisations (EGTOs)
- Provide a certificate of participation to students that acknowledges the support of CITB (template can be provided by CITB).
- Facilitate students to complete a post-program survey (CITB will provide a paper or online option)
- Acknowledge the support of CITB with the words "Proudly subsidised by CITB" and the doorways2construction logo on any promotional or marketing material.

Approval Criteria:

Considerations in application approvals include:

1	Previous Performance	Evaluation of the applicant's past performance and achievements.	
2	Duplication	Ensuring students/schools do not receive identical training from multiple sources.	
3	Geographical Spread	Consideration of the distribution of programs across the state to ensure equal access and opportunities for students in various regions.	
4	Industry Partnerships and Engagement	Assessment of the applicant's commitment to engaging industry stakeholders in the delivery of their program.	
5	Promotion of Diversity and Inclusion	Provide opportunities for students from diverse backgrounds and ensuring equal access to the program for all.

Application Process:

Preparation

Applicant to consult with partner school/s and or alliances/cluster schools, DfE Pathway Advisors (if applicable), identify potential industry partners to support your programs. Applications are open for programs that commence prior to 1 July 2024.

Submission (2 months) | 8 December to 28 February 2024

Applicant to complete the official application form available on citb.org.au and submit it along with all required documents.

Review and Approval (2 weeks) | After receipt of application

Applications will be reviewed by considering alignment with our application criteria and available budget.

Successful applicants will be notified of the funding approval and any specific terms and conditions associated with the funding confirming:

- funding subsidy total
- program reference numbers for each program
- invoicing requirements

Approvals may be impacted by CITB closure/skeleton staff between Christmas and early January.

Additional Programs

Throughout the year you may wish to apply for funding to deliver additional programs. Please do so through the website. Additional Programs will be limited to available budget.

Applications for Semester 2, 2024

CITB operates under an Annual Training Plan (ATP) approved by the Minister for Education, Training, and Skills. We will commence accepting applications for Semester 2, 2024 once our ATP is approved by the Minister. Recipients are advised to prepare funding applications in advance, ready for submission upon receiving approval.

Acronyms/Definitions

ATP

Annual Training Plan

The ATP outlines CITB's annual funding commitment and must be approved by the Minister for Education, Training and Skills each financial year.

CEPS

Career Education and Pathways Strategy

Part of Department for Education's efforts to improve the education, training and skills outcomes for South Australian students.

CITB

Construction Industry Training Board

A whole-of-industry led organisation that provides support to attract, train and retain South Australian building and construction workers by providing leadership in training and skills development.

D2C

Doorways2construction

An industry supported secondary schools' program that provides career education and Flexible Industry Programs (FIP) to attract students to a career in the building and construction industry.

VETRO

Vet Readiness Orientation

An upfront assessment, induction and orientation to VET carried out by an RTO.
